CIRCULAR NO JBA 51/2019
NOMINATIONS - EXECUTIVE COMMITTEE

In terms of Clause 6.3.2 of the Constitution, the election by ballot, of the Executive Committee of the Association will take place at the Annual General Meeting on **Sunday, 1 September 2019**.

A nomination form is appended to enable your Club, should it so wish, to make a nomination. Completed nomination forms and CV's must be returned to this office by not later than **Friday 2nd August 2019**, the closing date for nominations.

Within 5 days thereafter, details of those nominated for the elected positions will be sent to Clubs.

Attention is drawn to Clause 6.1.1 and 6.2.1 of the Constitution

6.1.1 *The Executive shall consist of 6 members, either male or female, not necessarily in equal proportion.*

6.2.1 *Each year every club shall have the right of nominating one person for each of the following positions*

6.2.1.1 *President*

6.2.1.2 *Vice President*

6.2.1.3 *Four office bearers to be elected for the exclusive positions as required:*

a. **Treasurer (Honorary):** *Responsibilities to ensure that the financial accounting of the Association is in accordance of clause 11 of the constitution.*

b. **Competition Secretary:** *Responsibilities to ensure that all draws, and competitions are run smoothly and in accordance with conditions of play and by-laws as they change from time to time.*

c. **Training and Transformation:** *Responsibilities to form and liaise with standing committees for Coaches and Disability Bowls and Transformation of Women in Sport, to ensure retention, advancement and growth of players in the district.*

d. **Technical manager:** *Responsibility to form and liaise with standing committees for the Technical officials, coaches and greens to ensure that the requirements of the District, Bowls South Africa and World Bowls are adhered to upheld.*

6.2.1.4. Each year every affiliated club shall have the opportunity of nominating suitable persons for each of the portfolios which shall comply with clause 6.1.1 of the Constitution.

The executive positions available for election are:

1. President
2. Vice President
3. Treasurer
4. Competition Secretary
5. Training and Transformation
6. Technical Manager
